### **Description**

This policy describes the medical necessity guidelines for nonpharmacological treatments for treatment-resistant depression (TRD), specifically electroconvulsive therapy, deep brain stimulation and transcranial direct current stimulation.

Transcranial magnetic stimulation (TMS) is addressed in policy WA.CP.BH.200.

#### Policy/Criteria

- I. It is the policy of Coordinated Care of Washington, Inc., and Coordinated Care Corporation, that electroconvulsive therapy is **medically necessary** for treatment resistant depression as defined in InterQual criteria.
- II. It is the policy of Coordinated Care of Washington, Inc., and Coordinated Care Corporation, in accordance with the Health Care Authority's Health Technology Assessment, that deep brain stimulation and transcranial direct current stimulation is **not medically necessary** for treatment resistant depression.

#### **Background**

This policy is based on Washington State Health Care Authority (HCA) Health Technology Assessment (HTA) and Health Care Authority Billing Guidelines.
