Description

This policy describes the medical necessity guidelines for upright or positional magnetic resonance imaging (MRI).

Policy/Criteria

I. It is the policy of Coordinated Care of Washington, Inc., and Coordinated Care Corporation, in accordance with the Health Care Authority's Health Technology Assessment (HTA) and Billing Guidelines, that use of upright/positional MRI is **not medically necessary**.
