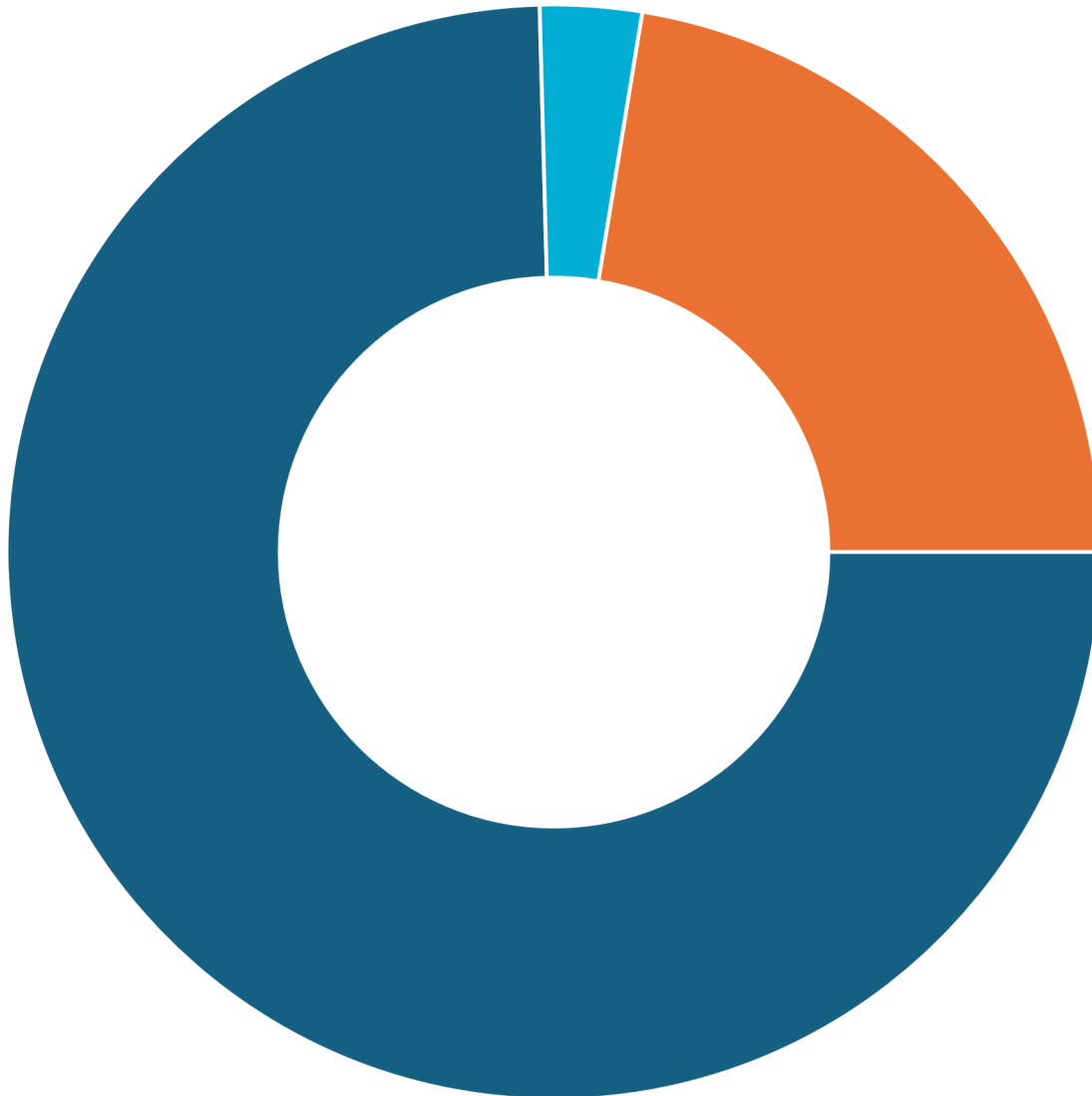

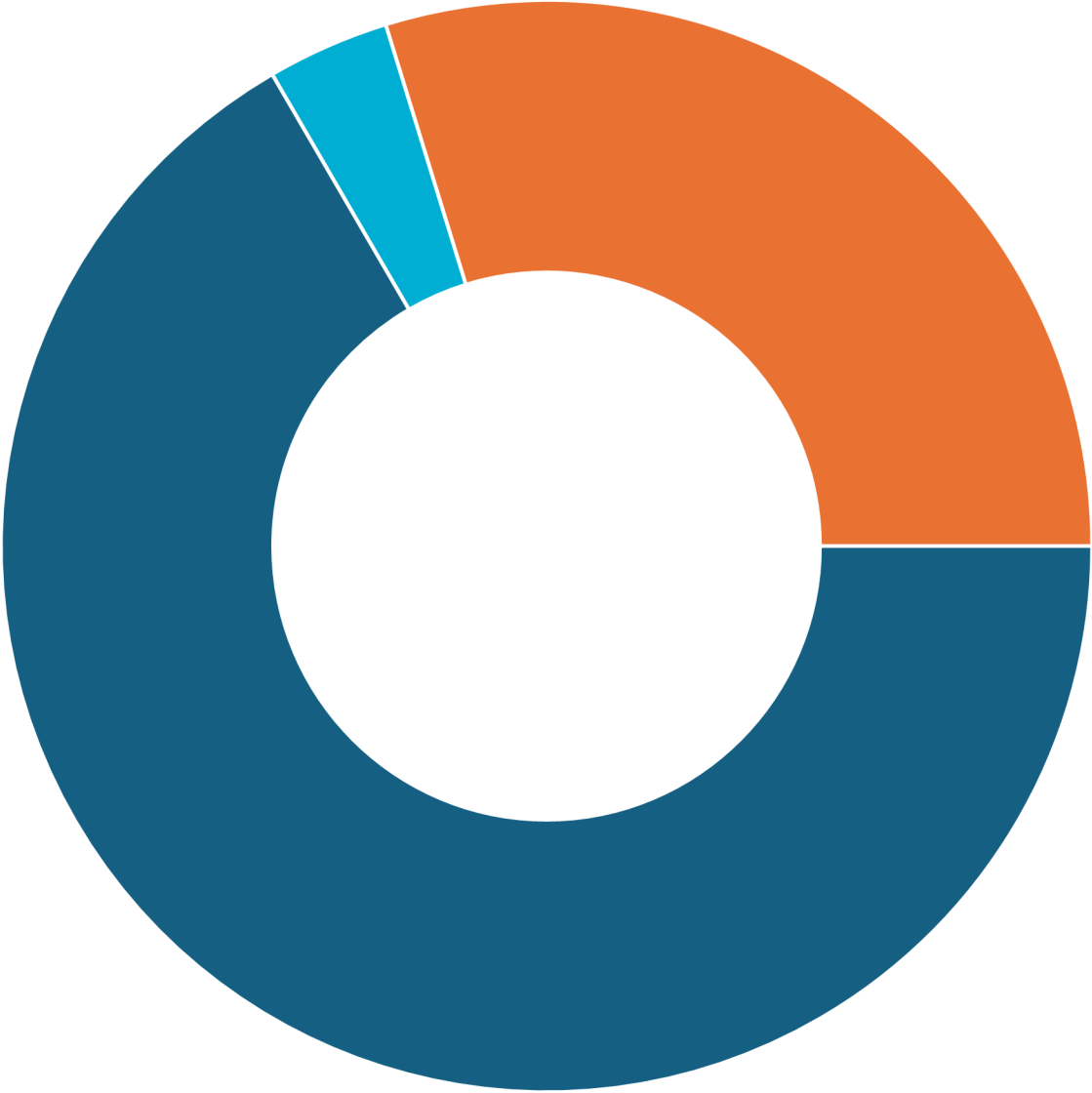
76.89% of those requests were approved:
