



2026 Ambetter Pay for Performance (P4P) Program

Program Purpose

The Ambetter P4P program is designed to enhance quality of care by focusing on preventive and screening services and member engagement. You are eligible to earn additional compensation beyond what you receive through your Participating Provider Agreement based on program performance. The program has no downside risk and does not require contract documentation to participate.

P4P provides additional compensation for engaging with our members and closing care gaps based on NCQA and HEDIS® quality performance standards. Each care gap has a target compensation amount which is provided for each compliant member event once the target has been achieved for that specific measure.



Program Overview

- ✓ HEDIS measures are evaluated using NCQA HEDIS guidelines, except the minimum qualified members per event, which is one (1), not thirty (30).
- ✓ Three disbursements are made (expected after Q2, Q3, and Q4 with Final Reconciliation mid-2027). Each report nets any prior disbursements against total earned.
- ✓ Gap closure rates/scores are accumulated based upon member's assigned PCP. The assigned PCP receives credit for closing gaps.
- ✓ Monthly performance reports and care gaps will be placed on the secure provider portal via Provider Analytics.
- ✓ There is no clawback provision for this program, so if a provider leaves the network mid-year or no longer has assigned membership, we will not recoup funds.

Program Measures and Compensation Rates

- ✓ Each measure is evaluated when there is at least one (1) qualified event in the denominator. Providers can qualify and receive compensation for one, multiple, or all measures.
- ✓ Target 1 is set at the Quality Rating System 3-Star target, and Target 2 is set at the Quality Rating System 4-Star target. Incentives are paid on each compliant member once the target is met for that measure.
